(“HOA”) GUIDE TO PENALTY LEVIES

While no-one wishes to turn St Francis Links into a sterile community, many decide to live in a disciplined environment where respect for one another and safety and security is paramount. To achieve harmonious living, there are conduct rules in place. They are supported by the content of this guide which provides for the most common and typical offences where penalty levies may be imposed in respect thereof by the HOA¹. However the quantum of the penalty levy applicable to any part of the offence shall be at the discretion of the HOA who shall take due regard of the nature, circumstances and severity of each misdemeanour, offence, breach or non-compliance.

This guide is not exhaustive and penalty levies may be imposed for offences not listed here. It should be noted that the penalty levy imposed for each and every subsequent occasion that an offence recurs or for every month or part thereof should an owner / member remain in breach, may result in an escalation of the quantum of the penalty levy imposed.

The interval between intermittent offences to be classified as repeat offences will be at the HOA's discretion. Persistent offences may in addition to or in place of higher penalty levies incur further action (legal or otherwise).

This penalty levy schedule may be reviewed by the Board of Directors from time to time. Penalty levies imposed for offences shall be deemed to be part of the levy due by the Owner. This may include the cost relating to repairs or replacement and / or legal services incurred as a result of such an offence.

The conduct of any visitors / contractors / guests of an owner / member remains the responsibility of such owner / member and penalty levies imposed will be charged to the owner / member. Homeowners should therefore inform their visitors / tenants of the Rules of the HOA before they take occupation.

3.4	Pets without collar and name tag including cats without a quick-release collar fitted with a bell			500 per event
